



Insurance

Customers that carry insurance which covers rented equipment (generally “property damage” or “inland marine”) insurance can decline the damage waiver (“DW”) referenced below by proving us with a Certificate of Insurance meeting the following requirements prior to commencement of each rental. The certificate should show proof of valid Liability and Rental Equipment coverage for the full replacement cost of the rented equipment. Complete Equipment Rentals, LLC (“CER”) should be listed as the certificate holder and added us as an additional insured and loss payee for the rented equipment. Such insurance must also be primary, non-contributory, include a severability of interests provision, and waive subrogation against CER.

A sample of a Certificate of Insurance is included on P2 for specific wording and for the required insurance coverage.

Damage Waiver

The damage waiver (“DW”) is designed to provide you with a limited waiver of claims by CER for physical damage to covered rented equipment which may occur while it is out on rent. The **DW IS NOT AN INSURANCE POLICY** and is not mandatory (you may decline it if you provide the insurance referenced above), and (provided you have paid the appropriate charge for damage waiver set forth on your rental contract prior to commencement of the applicable rental), will only cover accidental damage while using covered equipment properly and responsibly. Among other things, damage waiver will not cover any item(s): (a) with respect to which we do not offer, or you do not pay in advance for, damage waiver; (b) intentional damage; or (c) misuse or gross negligence. See your rental contract Terms and Conditions and our Damage Waiver Guide for additional details.

The damage waiver charge is 14% of the total base rental cost of each covered item.
